Advocate Manish Mohan has been practicing in the Supreme Court of India, Delhi High Court and other courts for the last twenty five years where he has appeared on matters relating to Constitutional, Criminal, Taxation, Arbitration, Labour and Service, Election and other Civil matters. He has also represented the states of Bihar, Jharkhand, Chattisgarh, Haryana, Meghalaya and Uttaranchal in the Supreme Court. He has also been elected to the Executive Committee of the Supreme Court Bar Association for two terms.

Advocate Mohan is also a prolific author and has co-authored more than a dozen law books on civil and criminal procedures and is at present working on a commentary on Prevention of Money Laundering Act.
